**REFUNDS:** There shall be no refunds for entries withdrawn after the closing date in the event a dog and/or handler are injured, absent, or dismissed from competition, regardless of the reason for such dismissal. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other cause beyond the control of the event organizing committee. No entry will be refunded in the event a dog is absent, disqualified, excused from competition by the action of the Trial Committee regardless of the reason for such dismissal. Refunds **are** allowed if requested before the closing date. Refunds allowed after closing listed below.

**Bitches in season:** Bitches in season are not eligible to participate in obedience trials. To receive a refund **NOTIFICATION MUST** be given to the trial secretary **PRIOR TO THE START OF JUDGING** on the first day the bitch is entered. ## DIRECTIONS TO UP FRONT DOG CENTER

**128 Arneytown-Hornerstown Rd Allentown, NJ 08501**

**From NJ Turnpike, Exit 7A** - Take I-195 East to Route 526 (Exit 7). Bear right onto Route 526 (Robbinsville Allentown Rd) to Main Street. Turn right onto Main Street. In 3/10 mi turn left onto High Street/ Route 539. Turn Right onto Holmes Mill Rd/Route 27, then right onto Arneytown-Hornerstown Road.

**From NJ Turnpike, Exit 7** - Take Route 206 North to Route 528 (Crosswicks Road). turn right on Route 528 and drive approximately 5 miles until Route 528 turns right. DO NOT TURN RIGHT - GO STRAIGHT (you are now on Route 664). Follow Route 664 and turn right to stay on 664 at the whirligigs on the RHS. If you pass Orr Rd on your left you have just missed the intersection (there is no street sign). Arneytown-Hornerstown Road is approximately 2 miles on your left. Up Front Dog Center is the 3rd driveway on the left, with the building at the end of a long driveway.

**From Freehold** - Follow Route 537 West. Turn right on Route 539 and sharp left (just past TKs Ice Cream on the LHS) onto Arneytown-Hornerstown Road. Will be on RHS approx 3 miles.

**From Mount Holly** - Follow Route 537 East. Turn left on Route 539 and left onto Arneytown-Hornerstown Road. Will be on RHS approx 3 miles.

## **\*\*\*TRIAL REGULATIONS FOR EXHIBITORS\*\*\***

- Fees are \$35.00 for the first entry of each dog and \$30.00 for each additional entry of the same dog for each Trial. All checks and money orders are payable to **SICDTC, Inc and mailed to PO Box 441, New Egypt, NJ 08533**
- Overnight deliveries must be "No Signature Required".
- Closing date for entries is 6:00 PM on Wednesday, January 17, 2024 at the Trial Secretary's address or when the judging time limit is reached, after which time entries cannot be accepted, cancelled or substituted except as provided for in Chapter 11, Section 6 of the Dog Show Rules. A wait list may be established to fill openings created by entries that are withdrawn prior to the Closing Date.
- Please clearly print or type all information on the entry form. Exhibitors are responsible for complete, accurate and legible information on the entry forms. Illegible or incomplete entries cannot be entered into the trial. All entries must be made on official AKC Entry Forms or copies and must include the Agreement and Rules.
- A wait-list will be established in order to fill openings created by entries that are withdrawn prior to the event closing day.
- Changes, additions or corrections to entry forms must be received in writing at the Trial Secretary's address or by e-mail prior to closing.
- Please show only AKC titles on the entry form.
- Your jump height must be included on the entry form for all classes that require a jump.
- Entries are acknowledged via e-mail as soon as they are processed. Judging Programs are sent via e-mail approximately one week before the trial date. If no acknowledgement is received by the Exhibitor within a reasonable time, please notify the Trial Secretary.
- Returned checks do not constitute a valid entry fee. The Trial Secretary will add a \$40.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitors may result in their being put on a MONEY ORDER ONLY basis.
- No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees, signatures or the "Agreement" on the reverse side of the Official AKC Entry Form.
- Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Show Committee deems the exhibitor to be in violation of this requirement. No dogs under 4 months of age on show grounds. No smoking in the building. Please dispose of all trash in the proper manner.
- The judge is not required to wait for dogs. It is the responsibility of the owner/handler to have the dog at ringside when required and without being called. All dogs present must be held on a leash, or confined to a crate except when being judged.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the sole discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The host club, its members, agents, employees, etc. will assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers, or to any of their dogs or property and further assume no responsibility for injury to children.
- Dogs only need to be present for scheduled judging and will be released if not needed for further judging.
- Dogs are only allowed in the ring while being judged.
- All dogs must be confined to their crates except when being judged.
- The Staten Island Companion Dog Training Club Inc. and Up Front Dog Center will not be held responsible for any accident that may occur to any person, animal, property or vehicle. The exhibitors shall hold the Trial Committee harmless and indemnify it against any legal proceedings arising from any accident.

## INSTRUCTIONS

- (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. - Dogs listed in the AKC Canine Partners™ Program may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
