DIRECTIONS TO UP FRONT DTC 128 Arneytown-Hornerstown Rd., Allentown, NJ 08501

From NJ Turnpike, Exit 7A - Take I-195 East to Route 526 (Exit 7). Bear right onto Route 526 (Robbinsville Allentown Rd) to Main Street. Turn right onto Main Street. In 3/10 mi turn left onto High Street/ Route 539. Turn Right onto Holmes Mill Rd/Route 27, then right onto Arneytown-Hornerstown Road.

From NJ Turnpike, Exit 7 - Take Route 206 North to Route 528 (Crosswicks Road). turn right on Route 528 and drive approximately 5 miles until Route 528 turns right. DO NOT TURN RIGHT - GO STRAIGHT (you are now on Route 664). Follow Route 664 and turn right to stay on 664 at the whirligigs on the RHS. If you pass Orr Rd on your left you have just missed the intersection (there is no street sign). Arneytown-Hornerstown Road is approximately 2 miles on your left. Up Front Dog Center is the 3rd driveway on the left, with the building at the end of a long driveway.

From Freehold - Follow Route 537 West. Turn right on Route 539 and sharp left (just past TKs Ice Cream on the LHS) onto Arneytown-Hornerstown Road. Will be on RHS approx 3 miles.

From Mount Holly - Follow Route 537 East. Turn left on Route 539 and left onto Arneytown-Hornerstown Road. Will be on RHS approx 3 miles.

In such case, no refund of any fees will be made.

FOOD will NOT be for sale at this trial. There are a number of fast food restaurants and eateries dose by the show site.

CONSULT JUDGING PROGRAM for time of judging.

REFUND CHECKS are void after 180 days and will NOT be re-issued.

THE TRIAL COMMITTEE will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, nor assume any liability in the event of an accident or misfortune to either dogs or exhibitors participating in this trial. A WAIT LIST will be established for this trial to fill openings created by entries that are withdrawn prior to the dosing day. The full entry fee will be refunded to an entrant whose entry is replaced by a wait-listed entry. An exhibitor placed on the wait list will be notified of receipt of entry and status on wait list.

NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.

ENTRY FEES will not be refunded in the event that a dog is absent, disqualified, excused by a veterinarian or the judge, or barred from competition by the action of the Trial Committee. If because of riots, civil disturbance or other acts beyond the control of the management it is impossible to open or to complete the trial, no refund of entry fee(s) will be made.

EXTREME WEATHER CONDITIONS, such as, but not limited to snowstorms, hurricanes, lightening, extreme heat must be considered for the health and safety of the dogs, exhibitors and spectators. The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to stop or cancel the trial before completion, no refund of entry fees will be made. If cancellation is decided before the event, every effort will be made to notify the exhibitors via the info provided on their entries. AS SPECIFIED IN CHAPTER 12, SECTION 4 of the AKC Rules Applying to Dog Shows, information contained on the entry form is required to be published in the club's show catalog. This information is also subject to publication in other media.

DOGS MAY ARRIVE any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.

JUDGES WILL NOT WAIT FOR ANY DOG HOLDING UP A CLASS. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their dasses are called to be judged.

JUDGING PROCEDURES may be modified to accommodate disabled handlers.

ALL DOGS PRESENT must be held on a leash or confined to their crates except when being judged or when in the exercise area.

- 1. (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehalred), Collles (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- 2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
- 3. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name. - 4. Dogs listed in the AKC Canine PartnersSM Program may be eligible to enter all-breed AKC Obedience trials at the club's option. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
