High In Trial Elite Awards

The Poodle Club of America, Inc. has made available a **Sterling Silver Medallion for Highest Scoring Poodle in Trial from Regular Classes**. To be eligible for the Medallion, a dog must be entered in at least one regular class in each of the two Obedience trials. That dog's two highest scores (one from each trial) will be used to tabulate the Highest Scoring Poodle in Trial. That dog will win the Poodle Club of America Sterling Silver Medallion and a gift of \$50 cash from Poodle Obedience Training Club of Greater New York. The winner will be determined at the conclusion of the second obedience trial of the day.

RALLY: The poodle with the highest combined scores from Advanced B, Excellent B, and Master classes, in each rally trial, will receive High Triple Q rosette and a poodle motif gift. From NJ Turnpike exit 7A: Take I-195 East to Route 526. Make a Right on Route 526 to Main Street. Make a Right on Main St. to Route 539. Make a Left on Route 539 to Arneytown-Hornerstown Road. Make a Right on Arneytown-Hornerstown Road.

From NJ Turnpike exit 7: Take Route 206 North to Route 528 (Crosswicks Road). Make a Right on Route 528; travel approximately 6 miles, Pass through 1 roundabout. and stay straight DO NOT TURN RIGHT . Stay straight to go onto Arneytown Chesterfield Rd/County Hwy-664, (Road is now Route 664). Follow Route 664; it will turn right; On the corner you note a house with weathervanes.
