Jump Height is required for all obedience classes with jumps. Classes with jumps will run in **ascending jump height order**, beginning with the lowest jump in all trials. Exceptions to jump height running order may be made for handlers with multiple entries.

Please note that the class orders listed above may vary on trial day.

Final confirmations and a judging schedule with the actual class running order will be emailed to all exhibitors after closing.

Entry fees:

From NJ Turnpike exit 7A: Take I-195 East to Route 526. Make a Right on Route 526 to Main Street. Make a Right on Main St. to Route 539. Make a Left on Route 539 to Arneytown-Hornerstown Road. Make a Right on Arneytown-Hornerstown Road.

From NJ Turnpike exit 7: Take Route 206 North to Route 528 (Crosswicks Road). Make a Right on Route 528; travel approximately 6 miles, Pass through 1 roundabout. and stay straight DO NOT TURN RIGHT . Stay straight to go onto Arneytown Chesterfield Rd/County Hwy-664, (Road is now Route 664). Follow Route 664; it will turn right; On the corner you note a house with windmills. Continue to follow County Hwy-664 for approximately 2 miles. Turn left onto Arneytown Hornerstown Rd. Go approximately 0.49 mile on your left. A blue flag will be in front with the name Upfront Dog Center.

RETURNED CHECKS do not constitute a valid entry fee. A charge of \$30.00 will be made for each returned check.

TELEPHONE AND UNSIGNED ENTRIES cannot be accepted.

ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS without the Agreement and Rules attached to the Official AKC Entry Form are **NOT ACCEPTABLE.**

ENTRIES RECEIVED WITHOUT FEES will not be accepted.

(Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
2. (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.

These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.

AGREEMENT
