The Poodle Club of America, Inc. has made available a **Sterling Silver Medallion for Highest Scoring Poodle from Regular Classes in Each Trial**. To be eligible for the Medallion, a dog must be entered in at least one regular class in one of the two Obedience trials. That dog's highest score will be used to tabulate the Highest Scoring Poodle in Trial. (In event of tied scores, a judge will be designated to conduct a run-off.) That dog will win the Poodle Club of America Sterling Silver Medallion and a gift from Poodle Obedience Training Club of Greater New York. The winner will be determined at the conclusion of the each obedience trial. A special POTC engraved glass urn will be awarded to the Poodle with the highest combined scores from Trial One and Trial Two.

**REFUNDS:** There shall be no refunds for entries withdrawn after the closing date except for bitches in season. No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, an act of God, public emergency, act of public enemy, or any other cause beyond the control of the event organizing committee. No entry will be refunded in the event a dog is absent, disqualified or excused from competition by the action of the Trial Committee regardless of the reason for such dismissal. There is a \$5.00 processing fee for **ALL** refunds. **No refunds for overpayments of \$10 or less.**

**Bitches in season:** For AKC events, Bitches in season are not eligible to participate in obedience or rally trials. Entry fees will be refunded less a \$5.00 processing fee. To receive a refund, **NOTIFICATION MUST** be given to the Trial Secretary **PRIOR TO THE START OF JUDGING** on the day in which the bitch is entered. Written verification from a veterinarian is also **REQUIRED** & must be RECEIVED with a copy of the dog's final confirmation. **Please scan & email these documents to Fast Times or send them via fax to 888-521-1706.**

Most GPS devices will get you there, make sure you see the flag on the driveway

**From NJ Turnpike exit 7A:** Take I-195 East to Route 526. Make a Right on Route 526 to Main Street. Make a Right on Main St. to Route 539. Make a Left on Route 539 to Arneytown-Hornerstown Road. Make a Right on Arneytown-Hornerstown Road.

**From NJ Turnpike exit 7:** Take Route 206 North to Route 528 (Crosswicks Road).

Make a Right on Route 528; travel approximately 6 miles, Pass through 1 roundabout. and stay straight. DO NOT TURN RIGHT. Stay straight to go onto Arneytown Chesterfield Rd/County Hwy-664, (Road is called Route 664). Follow Route 664; it will make sharp right turn; at the corner you note a birdhouses with weathervanes. Continue to follow Route 664 for approximately 2 miles. Turn left onto Arneytown Hornerstown Rd. Go approximately a half mile on your left. A white dog silhouette will be hanging in front of long driveway.

**From Freehold:** Start out going southwest on W Main St/County Hwy-537 toward Throckmorton St/County Hwy-522. Continue to follow County Hwy-537. Follow Route 537 West. Turn Right on Route 539. Turn Left on Arneytown-Hornerstown Rd. Go approximately 0.49 mile on your left. A white dog silhouette will be hanging in front of long driveway.

**From Mount Holly:** Follow Route 537 East. Turn Left on Route 539. Turn Left on Arneytown-Hornerstown Road. A white dog silhouette will be hanging in front of long driveway.

## **\*\*\*\*TRIAL REGULATIONS FOR EXHIBITORS\*\*\***

**RETURNED CHECKS** do not constitute a valid entry fee. A charge of \$30.00 will be made for each returned check.

**TELEPHONE AND UNSIGNED ENTRIES** cannot be accepted.

**ENTRIES NOT ON OFFICIAL AKC ENTRY FORMS OR PHOTOCOPIES OF ENTRY FORMS** without the Agreement and Rules attached to the Official AKC Entry Form are **NOT ACCEPTABLE**.

**ENTRIES RECEIVED WITHOUT FEES** will not be accepted.

**NO ENTRY SHALL BE MADE AND NO ENTRY SHALL BE ACCEPTED WHICH SPECIFIES ANY CONDITIONS AS TO ITS ACCEPTANCE.**

**ACKNOWLEDGEMENT OF ENTRIES** will be made as soon as trial closes or limits are reached.

Acknowledgment of entries will include confirmation notices.

**ENTRY FEES** shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of Trial Committee. If because of riots, civil disturbances or other acts beyond the control of the management, it is impossible to open or to complete the match, no refund of entry fees will be made.
